Candidates NOT Studying in any institution

The following original certificates should be submitted.

1. Allotment Memo.
2. **10th Certificate** for verifying Name, Address & Date of Birth. If the Date of Birth is not included in the 10th Certificate, produce another Document like Birth Certificate, etc.
3. Admit Card for the Entrance Examination.
4. Originals of Degree Certificate and Mark list of all parts of the qualifying exam – Passed Three years/Two years (Lateral Entry) Diploma in Engineering and Technology OR D.Voc. awarded from State Board of Technical Education/Universities or Institutions under Govt. of India, undergoing studies at AICTE approved Institutions OR Candidates who have passed B.Sc. degree from a recognized university as defined by the UGC with Mathematics at 10+2 are eligible to apply from the Lateral Entry Test subject to fulfilling the requirements of minimum marks as contained clauses 4.1.1 and 4.1.2 (for students coming from diverse background, the universities will offer suitable bridge courses related to Mathematics, Physics, Engineering drawing etc. to achieve desired learning outcomes of the programme.
5. Transfer Certificate from the institution where the candidate studied last.
6. Conduct Certificate (issued after 1st April 2024)
7. Eligibility Certificate - Candidates who have acquired/are acquiring the eligibility for qualifying from Board/University outside Kerala State or Board/University outside India should produce an equivalency certificate from the Directorate of Technical Education/Universities in Kerala. For diploma/D.Voc eligibility shall be from the Directorate of Technical Education and for Degree it shall be from any of the Universities in Kerala.
8. **Nativity of the candidate** (from Village Officer or competent authority) or True copy of the Birth Certificate issued by the competent authority/passport/school certificate showing the place of birth.
9. Valid (One year) **Non-Creamy Layer certificate** – for communal reservation seat – belonging to Ezhava (EZ), Muslim (MU), Other Backward Hindus (BH), Latin Catholic & Anglo Indians (LC), Dhevara and related communities (DV), Viswakarma and related communities (VK), Kusavan and related communities (KN), Other Backward Christian (BX) and Kudumbi communities (KU).
10. Valid (Three years) **Community Certificate** from Tahsildar for SC/ST reservation.
11. For (One year) **Fee concession to OEC category** – Certificate to prove community. Certificate to prove community and Income certificate (up to Rs.6 lakhs) is required from the Village Officer
12. Fee concession to **children of Fishermen** – certificate from Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board.
13. Fee concession to inmates of **Sri Chitra Home, Nirbhaya Home & Juvenile Home** - certificate from Director, Women and Child development.
14. **PD Quota** – Certificate from Medical Board.
15. Applicant who is employed or a trainee in Government service, Scheduled Bank, etc. should produce, at the time of the interview, a relieving order and a certificate of good conduct from the Head of the office where the applicant is employed.
16. The student who qualifies from other universities should produce a migration certificate at the time of admission.

 19. Undertaking from the Students as per the provisions of the anti-ragging verdict by the Hon'ble Supreme Court of India.
