The following guidelines are laid down for admission sponsored . candidates to full time PG degree programmes.

The candidates who possess Bachelor's degree in Engineering (i) /Technology / Pharmacy / Architecture / Planning or equivalent from AICTE approved institutions which at least 55% marks will be eligible

The minimum percentage of marks may be waived for those who are teachers either in Engineering college or Polytechnic joined before 28-02-1989, the date on which the circular was issued prescribing the AICTE pay scales and qualifications.

Preference should be given to those candidates who are GATE qualified. Sponsored candidates will not be eligible to receive Scholarship, even if they are admitted based on GATE score.

- The candidates must have a minimum two years of full-time work (ii) in a registered firm/company/industry/educational and research Autonomous Organizations in the relevant field in which admission is
- There will not be any age restriction. However, preference should be (111) those who are below 45 years of age.
- The mode of selection shall be such that merit is the sole criterion No (IV) capitation fee or donation will be charged for admission.



The minimum percentage of marks may be waived for those who are teachers either in Engineering college or Polytechnic joined before 28-02-1989, the date on which the circular was issued prescribing the AICTE pay scales and qualifications.

Preference should be given to those candidates who are GATE qualified. Sponsored candidates will not be eligible to receive Scholarship, even if they are admitted based on GATE score.

- (ii) The candidates must have a minimum two years of full-time work experience in a registered firm/company/industry/educational and research institutions/any Government Department of Government Autonomous Organizations in the relevant field in which admission is being sought.
- (iii) There will not be any age restriction. However, preference should be given to those who are below 45 years of age.
- (iv) The mode of selection shall be such that merit is the sole criterion No capitation fee or donation will be charged for admission.
- (v) A letter from the employer must be furnished stating that the candidate is being sponsored t get admission. The employer should also indicate that the candidates will not be withdrawn midway till the completion of the courses.
